- ▶ All Single Memberships are required to spend \$20.00 on food (excludes tax & gratuity) monthly.
- ▶ All Family/Couple Memberships are required to spend \$40.00 on food (excludes tax & gratuity) monthly.
- ▶ All Active Memberships require the payment of a one-time membership Certificate fee of \$100.00. The certificate fee can be paid in installments of four if so desired.
- ▶ Locker Rental is available for onsite storage.
- ▶ Cart Storage available - One-time \$360.00 Fee, \$100.00 annually thereafter (Gas Carts) or \$140.00 annually thereafter (Electrical Carts)
- ▶ The club's board may elect to assess members on an annual basis after their first year of membership - at a rate of up to \$200 for family golf members and up to \$100 for social, single and junior members - to be used to pay club debt.

*Any of the above dues, fees, or charges may be changed by a vote of the Certificate holders.
